TERMS & CONDITIONS

Welcome to the On a Mission Membership at ClarityMD. By enrolling in this membership, you agree to the following terms and conditions:

1. Membership Overview

The On a Mission Membership provides exclusive access to premium skin treatments designed to help you achieve your best skin yet. Members receive one treatment per month, with the flexibility to bank unused treatments for future use or apply the monthly value toward an upgraded service.

2. Membership Benefits & Pricing

- \$250 per month (billed on the 1st of every month) or \$2,750 annually (prepaid option).
- Members receive one treatment per month from the options below.
- Unused treatments may be banked and redeemed within 365 days from the original billing date.
- The monthly membership value (\$250) may be applied toward upgraded services, but cannot be used for product purchases.
- Members receive a premium skincare welcome gift.
- Members receive 10% off all skincare products.

4. Membership Fees & Payments

- Membership fees are non-refundable and are charged monthly or annually based on the selected payment plan.
- Payments are processed on a recurring basis via the payment method on file.
- Any changes to membership pricing will be communicated at least 30 days in advance.

5. Appointment Scheduling & Cancellations

- No-shows or cancellations within 24 hours may result in forfeiting that month's treatment value.

6. Membership Term & Cancellation Policy

- The membership requires a minimum 6-month commitment from the enrollment date.
- After the initial 6-month period, the membership will continue on a month-to-month basis unless canceled.
- To cancel after the lock-in period, a 30-day notice is required. Cancellation requests can be submitted via email or in person at ClarityMD.
- If canceling before the 6-month commitment is fulfilled, an early termination fee of \$250 may apply.

7. Treatment Eligibility & Customization

- Treatments are subject to provider approval to ensure suitability based on skin conditions and goals.
- ClarityMD reserves the right to adjust treatment options to maintain the highest standard of care.

8. Additional Terms

- Membership cannot be combined with other promotions or discounts.
- ClarityMD reserves the right to modify, suspend, or terminate the membership program with a 30-day notice to members.
